THE 1992 AUTUMN CENTURY RIDE 50 Mile Route

RIDE SINGLE FILE ON ALL HIGHWAYS. OBEY ALL TRAFFIC RULES. RIDE DEFENSIVELY.

START TIME: 9:00a.m.
Start and Finish at Pzazze' Pizza, Wandermere Mall, No. Division & Hastings.
Roadway is marked at all intersections.

MILES/TURNS/ROAD NOTES

0.0	R	Hastings. Rd. (Cross Division at Traffic Light)
0.9	R	Mill Road
2.3	L	Sharp left at the bottom of Mill Hill after Stop Sign. Take special care while moving toward the center of the road downhill!
6.5	L	Monroe Road. Follow general curve of road (double yellow line).
7.3	X	Cross Austin Rd. Rolling hills ahead.
10.9	R	Right turn at Monroe/Hazard at Cemetery. Head north.
11.9	X	Cross Wild Rose. Outhouses at Wildrose Community Center.
15.8	X	Cross Burroughs Rd. Head North.
17.8	X	Cross Hwy. 395. Road becomes Crawford. Continue for 1/2 mile.
18.3	L	Left on to Park.
18.5	R	Right on to Northwest. Follow contour of road.
18.6	L	Left into Deer Park City Park. FOOD STOP #1, restrooms and water.
		NOTE: This food stop is open from 8:30am -1:30pm only.
18.7	X/L	Cross railroad tracks and immediate left on North Rd. Proceed north.
20.9	L	Left on to Montgomery Rd. Proceed east. Follow bends in road.
22.9	X	Spotted Rd. Continue west on Montgomery.
23.7	X/R	Cross railroad track. Right turn on to Hwy. 395 to Clayton. Enter Stevens County.
24.3	R	Turn right into Clayton and Clayton Drive Inn. Restrooms, water. Continue into Clayton on loop rd. (Follow yellow line.)
25.2	L	Bear left off Clayton loop rd at school to Hwy. 395.
25.5	X	Cross Hwy. 395, store on right. Continue west on Williams Valley Rd. Road curves to south.
28.6	L	Left on to Gibson Rd. Travel east.
30.6	S	Gibson changes to Laurel/Dahl Rd. Continue east, into Spokane County.
31.1	S	Darigold milk carton on left.
31.5	S	Spotted Rd. Continue east.

MILES/TURNS/ROAD NOTES

32.8	X	Cross Hwy. 395. Continue on Dahl Rd. BPA Deer Park Substation on right. (Be careful of traffic).
33.5	R	Right into Deer Park City Park. FOOD STOP #2. Open until 1:30p.m. Restrooms, water.
33.6	X/L	Cross railroad tracks and immediate right onto Railroad St.
34.0	L	Left on to Crawford to junction of Main and Crawford.
34.0	X	Continue across intersection on Crawford. (Becomes Deer Park-Milan Rd.)
36.1	R	Right on to Cedar Rd. Continue south.
39.3	L	Cross railroad tracks and turn left on North Rd.
39.8	X	Cross Denison-Chatteroy Rd. Proceed south on North Rd.
40.7	L	Cross Hwy. 395 and proceed south on Hwy 395. CAUTION!
42.9	L	Left on to Half Moon Rd. Proceed east. CAUTION!
43.9	S	Half Moon Grange on right, outhouses. Sleep downhill.
44.4	R	Right at bottom of hill on to Perry Rd. Continue on Perry Rd.
45.5	S	Junction with Burke Rd. Continue on Perry Rd.
46.0	R	Right on to Little Spokane. Continue south. Then bear left (actually straight) on to Shady Slope and uphill.
50.8	R	Right from Shady Slope on to Hwy. 2.
51.1	R	Right on to Farwell Rd to finish at Pzazze' Pizza.
52.3	R	Right into Pzazze' Pizza and check-in.
